

Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. **COVID-19 is extremely contagious** and is believed to spread mainly from person-to-person contact. As a result, **Worldwide** governments and health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

Infusion Dance Company has put in place preventative measures to reduce the spread of COVID-19; however, **Infusion Dance Company cannot guarantee** that you or your child(ren) will not become infected with the virus. Further, **attending Infusion Dance Company could increase** your risk and your child(ren)'s risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending **Infusion Dance Company** and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at **Infusion Dance Company** may result from the actions, omissions, or negligence of myself and others, including, but not limited to **Infusion Dance Company** employees, independent contractors, volunteers, and program participants and their families.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with mine or my child(ren)'s attendance at **Infusion Dance Company** or participation in **Infusion Dance Company** programming either at the studio or hired location. ("Claims"). On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless **Infusion Dance Company**, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of, **Infusion Dance Company** its employees, independent contractors, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any **Infusion Dance Company** program.

NOTE: Returning to **Infusion Dance Company**, is permissible only if the following guidelines have been met.

- My child/ I will not attend any Infusion Dance Company classes if suffering with illness or showing any of the known covid-19 symptoms such as fever, cough or loss of taste/smell.
- My child/ I will not attend any Infusion Dance Company classes if any of my relatives (living with me) have been diagnosed or have Covid-19 and will only return once the isolation period has ended.
- My child/ I will not attend any Infusion Dance Company classes if we must quarantine or self isolate due to reasons such as traveling abroad or being advised to do so by NHS track and trace.
- My child/I agree to follow the proper hygiene and safety guidelines put into effect by **Infusion Dance Company**, from the council of the Health Department (Including wearing masks unless dancing, frequent hand sanitization, and maintaining social distancing)

(Dancers with signs of illness or unable to conform to the **Infusion Dance Company**, guidelines listed above MUST remain home.
